MARKET ANNOUNCEMENT

NTA Backing as at 31 May 2018

Bentley Capital Limited (ASX Code: BEL) gives notice that its unaudited after-tax Net Tangible Assets (NTA) Backing as at 31 May 2018 was \$0.1291 per share.

Bentley notes that the decline in NTA backing was principally caused by a \$1.1 million reduction (equivalent to 1.44 cent per Bentley share) in the carrying value of the Company's investment in Keybridge Capital Limited (ASX:KBC) (**KBC**). This resulted from KBC re-valuing its investment in Molopo Energy Limited (ASX:MPO) (**MPO**) from 14 to 4.5 cents per share during the month, leading to a provision for impairment expense being recognised of ~\$4.72 million (which is equivalent to ~3 cents per KBC share).

KBC has advised that this revaluation has occurred as a consequence of the conduct of the previous MPO Board¹ having entered into a series of transactions which have caused a reduction of US\$35 million (or nearly A\$50 million) in MPO's cash reserves in circumstances where such conduct have been the subject of:

- A declaration of 'unacceptable circumstances' by the Takeovers Panel²; and
- The ASX issuing a 'Breaches Letter' where ASX advised that it considers that MPO has committed serious breaches of the ASX Listing Rules and may also have breached the Corporations Act for making misleading disclosures to ASX and as such, ASX has referred their findings to ASIC for further investigation³.

KBC has advised that it will re-assess the carrying value of the company's investment in MPO based on further information about MPO's financial position, as released on ASX by MPO.

NOTES:

- (1) Bentley's investment in Keybridge Capital Limited (ASX: KBC) is regarded as an Associate entity (over which Bentley is considered to have significant influence) and is accounted for under the equity method in the consolidated financial statements pursuant to Accounting Standard AASB 128. Under the equity method, the carrying amount of an investment in an Associate entity is at initial cost plus a share of the Associate entity's net profit or loss (after tax) for the financial year to the relevant balance date. Refer Note 22 (Investment in Associate Entity) on page 53 of Bentley's 2017 Annual Report for further information in this regard.
 - Bentley has accounted for its investment in KBC (31,700,000 shares being 20.05% of KBC's total issued share capital) (30 April: 31,700,000 shares; 20.05%) at a carrying value of \$2.69 million (being \$0.085 per share) at month end on this basis. Bentley notes that KBC's closing bid price on ASX was \$0.09 and its net asset backing was \$0.1090, as at month end (30 April: \$0.094 share price and \$0.1431 net asset backing).
- (2) Bentley's investment in <u>Strike Resources Limited</u> (ASX:<u>SRK</u>) is regarded as an investment in a Non-Current Asset Held For Sale and is accounted for under Accounting Standard <u>AASB 5</u>. Refer Note 9 (Non-Current Asset Held for Sale) on pages 41 and 42 of Bentley's <u>2017 Annual Report</u> for further information in this regard.
 - Bentley has accounted for its investment in SRK (52,553,493 shares being 36.16% of SRK's total issued share capital) (30 April: 52,553,493 shares; 36.16%) at a carrying value of \$3 million (based on the closing bid price on ASX of 0.057 cents per share) at month end on this basis (30 April: \$2.89 million; 0.055 cents).
- (3) Units invested in the CBG Australian Equities Fund (Wholesale) (**CBG Fund**) are valued at the audited unit price published by the investment manager, <u>CBG Asset Management Limited</u>, as at month end the unit price reflects the net asset backing of the fund; there is no buy/sell spread price; there is no recognition of realisation costs as there are no exit fees charged on redemption of units.
- (4) The post-tax NTA Backing per share figure is reported net of provision for tax liabilities on realised and unrealised gains on investments, in accordance with the Company's income tax accounting policy (refer Note 5 (Tax) at page 38 of Bentley's 2017 Annual Report for further information in this regard.
- (5) Bentley's current accounting policy is to recognise deferred tax assets arising from its carried forward tax losses and its unrealised loss on investments only to the extent of offsetting any deferred tax liabilities arising from its unrealised gains on investments.
- (6) Bentley's current accounting policy uses the first in-first out method of calculating gains or losses on sales of share investments.
